MINUTES OF PREVIOUS MEETINGS – Councilor Schnaars made a motion, duly seconded by Councilor Ruff, to approve the following minutes: Council Meeting of January 11, 2021; Committee Meetings – January 18, 2021, and January 25, 2021; Special Council Meeting of January 25, 2021. President Reed declared the motion passed following a Voice Vote, All in Favor.

<u>Jeralyn Schoch</u> – 301 E. Church Street. Signed in and was recognized to speak. Jeralyn Schoch provided a petition, and pictures, to the Council. This petition states that she, along with her fellow neighbors, they are requesting that the Borough Council address the issues which are currently occurring at the property listed at 315 and 325 E. Church Street. Jerilyn stated that at this time they have a rat infestation, which is a safety and sanitary issue. Since rats' chew through wires, they are concerned that one day there will be a fire on their property. Jeralyn gave Tony Lopsonzski kudos for working diligently to correct this issue. This petition is requesting that the Borough work on getting these properties condemned. Jeralyn described the condition of 325 E Church Street with garbage being all over the place, mold, and the stability of the structure. These properties are owned by the same landlord. Attorney Healy stated that an inspection would have to be done first to determine the condition. Jeralyn asked about her request at the meeting of June 15<sup>th</sup> to move the radar speed sign from Main Street to Church Street due to speeding. Chief Rachman asked where she would like to have it put. Jeralyn requested it be placed near her house. Chief Rachman has agreed to have the sign moved to Church Street. Councilor Bartholomew asked Attorney Healy if there is a time line for condemning the property. Attorney Healy stated, citations must be issued, then you must obtain an injunction, etc. This is not a rapid process.

<u>Jeff Hausman</u> – 46 So. Walnut Street. Signed in and was recognized to speak. Jeff Hausman wanted to thank the Borough crew for an exceptional job on snow plowing with the last storm. Jeff asked the Council if they would ever consider hiring an outside contractor to help with the snow removal.

<u>Ciera Schoenberger</u> – 323 E. Church Street. Signed in and was recognized to speak. Ciera Schoenberger lives next to 325 E. Church Street. Ciera also complained concerning the rat issue. Ciera provided items showing the damage the rats are doing to her childrens' clothing. Ciera has requested a certified exterminator from her landlord. The landlord sends his own employee. Ciera is having multiple problems/concerns with her landlord. The Council agreed to discuss this with Tony Lopsonzski.
