

ORDINANCE 633

AN ORDINANCE OF THE BOROUGH OF SLATINGTON, LEHIGH COUNTY, PENNSYLVANIA ESTABLISHING CERTAIN FEES AND COSTS AND ALLOWING ALL FEES TO BE FIXED BY RESOLUTION.

Section 1. BE IT HEREBY ORDAINED that the Borough Council of the Borough of Slatington hereby accepts the following Fee Schedule effective the date executed below:

2008 Fee Schedule for Building and Zoning Permits

Building Permits***:

- 1. Sheds / Decks - first 100 sq. feet of construction \$ 25.00*
2. Garage or Addition - first 100 sq. feet of construction \$ 50.00*
3. New Construction - first 100 sq. feet of construction \$100.00**
4. Sign Permit \$ 15.00
5. Zoning Permit \$ 25.00***
6. Business Occupancy Permit \$ 25.00***
7. Home Occupation Permit \$ 25.00***
8. Residential Occupancy Permit (new homes only) \$ 25.00***

* Plus \$5.00 per each additional 100 sq. feet or part thereof.
** For non-residential structures a Fire Permit must be obtained before an occupancy permit can be issued.
*** Plus fees for required inspections under the PUC (PA Uniform Construction Code).

Moving Permit - \$10.00

Peddling and Soliciting Permit/License - \$25.00/day

Yard Sale Permit - \$10.00

AFTER THE FACT PERMIT will be double the normal cost


Section 2. All permit, license and ticket fees, including but not limited to those listed above, may hereafter be altered by Resolution of the Borough Council as it deems appropriate.

Section 3. All Ordinances or parts of Ordinances, insofar as the same shall be inconsistent herewith, shall be and the same expressly are repealed.




