Justin informed the committee that they have 1 applicant for the fire police captain and would like this placed on the next regular council agenda to approve Jeremy Henry as fire police captain.

Jeffrey Hausman – 46 So. Walnut Street. Signed in and was recognized to speak. Jeffrey would like to ask the council to reconsider their thoughts on the current ordinance for fire chief. Jeffrey would like to see the council amend Ordinance 684, Chapter 22, Section 2a-3, to open it up so that the fire chief could be allowed to live outside of the school district. Jeffrey has spoken to other fire departments and most of them do not require the firechief to live in the school district. This will be placed on the February committee agenda. Jeffrey stated that years ago when monies are left over at the end of the year, that money went to the fire truck fund.

Councilor Kratz suggested to obtain the lights and decide if the borough wants to maintain them later. This will be placed on the next regular council agenda.
